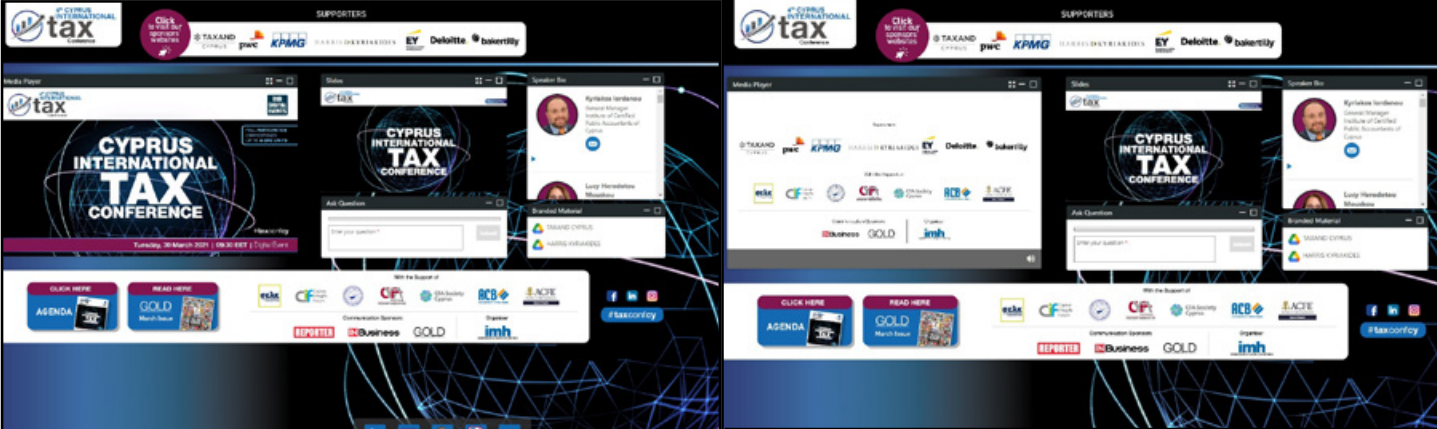

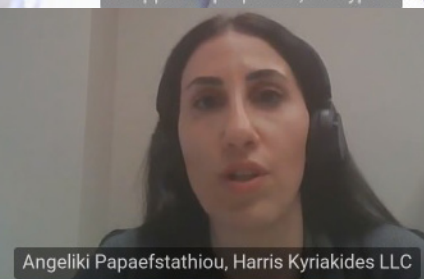


POST EVENT REPORT

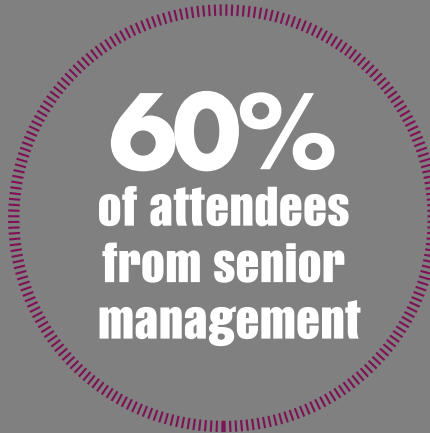

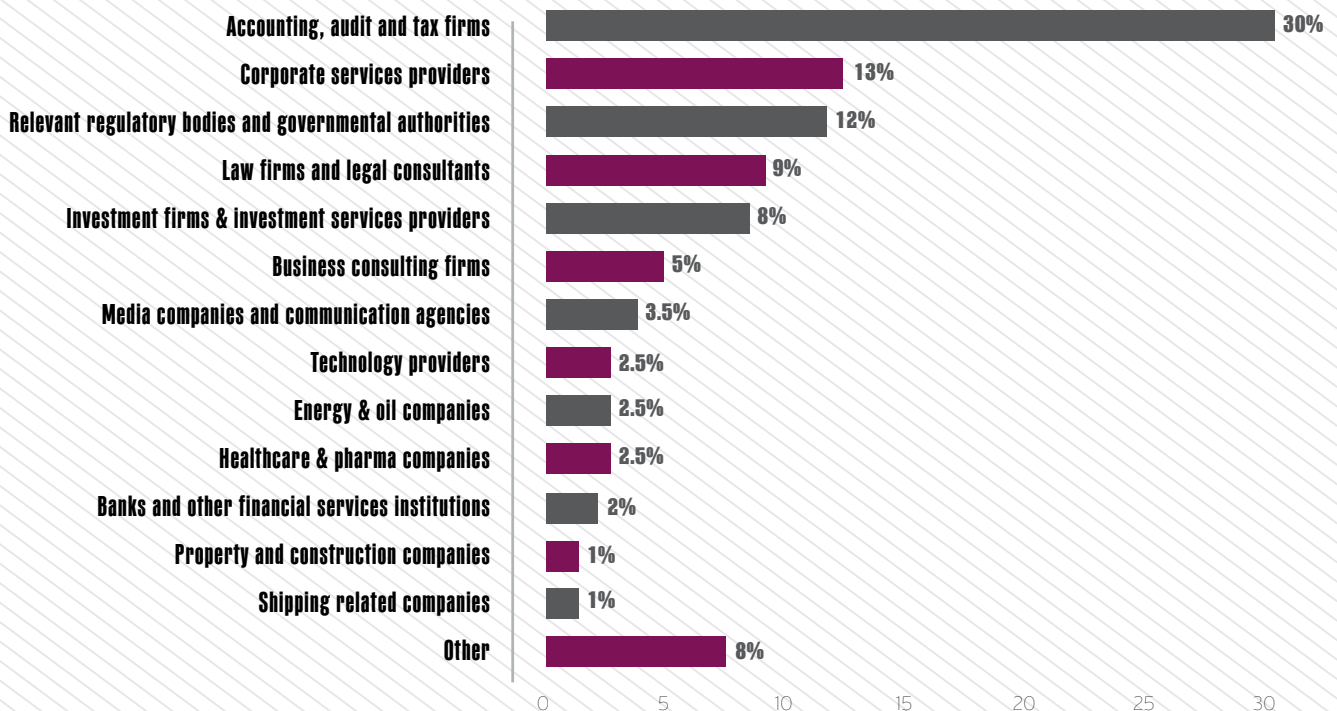
